TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$65.90 billion in 2021. The preliminary agricultural adjusted figure for 2021 is \$70.57 billion.^C
- Since 2009, Illinois exports have increased by \$24.28 billion, or 58.3%
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, a record, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^C
- 20 out of top 20 export industries increased 2020 to 2021
- 18 out of top 20 export industries increased 2009 to 2021
- Top 10 Illinois export industries have seen gains since 2009
- 9 of the top 10 Illinois export partner countries have seen gains since 2009
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Colombia in 2021

- Illinois exports to Colombia totaled \$403.3 million in 2021, a 48.6% increase since 2009. Colombia is Illinois' 27th largest export market
- Illinois ranks 7th among the 50 U.S. states in exports to Colombia
- Illinois imports from Colombia totaled \$59.4 million in 2021, a 23.3% increase since 2009. Colombia is Illinois' 63rd largest import market
- Illinois ranks 20th among the 50 U.S. states in imports from Colombia

Colombian Foreign Direct Investment in Illinois^D

- Illinois ranks #3 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,634 foreign firms that employ more than 380,503 Illinois residents
- Colombian firms employ 20 Illinoisans at 2 distinct locations for 2 subsidiaries
- Colombia is Illinois' 48th largest FDI partner by employment

^C: Export statistics are based on Origin of Movement methodology by the Census Bureau which collects information from the Customs and Border Protection from bills of lading. Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commodity trading firms maybe the exporter of record even though the products came from a different state/producer.

For the State of Illinois, analytical adjustments of census data by WISER Trade using USDA farm cash receipts yields a 2021 export total of 70.57 Billion a \$4.67 Billion-dollar difference. Boosts Illinois to 4th position nationwide. Agricultural adjusted trade figures are only available from 2012. Rank tied in 2012, 2014, 2019, 2020, 2021
