## TRADE AND INVESTMENT STATISTICS

### Exports are a Vital Part of Illinois' Economy<sup>A</sup>

- Preliminary Illinois exports totaled over \$80.82 billion in 2024, a 2.5% increase from 2023, and a 35.2% increase from 2019. The preliminary agricultural adjusted figure for 2024 is \$81.97 billion, a 0.9% increase from 2023 and a 32.2% increase from 2019.
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.<sup>C</sup>
- 13 out of top 20 export industries increased since 2023.
- 18 out of top 20 export industries increased since 2019.
- 12 of the top 20 Illinois export partner countries have seen gains since 2023.
- 19 of the top 20 Illinois export partner countries have seen gains since 2019.
- Export activities support over 800K jobs in Illinois.<sup>B</sup>

### Total Trade between Illinois and Australia in 2024

- Illinois exports to Australia totaled \$4.71 billion in 2024, a 7.5% increase from 2023 and a 35.8% increase from 2019. Australia is Illinois' 3rd largest export market.
- Illinois ranks 1st among the 50 U.S. states in exports to Australia.
- Illinois imports from Australia totaled \$964.1 million in 2024, a 6.0% decrease from 2023 and a 6.5% decrease since 2019. Australia is Illinois' 25th largest import market.
- Illinois ranks 6th among the 50 U.S. states in imports from Australia.

### Australian Foreign Direct Investment in Illinois<sup>D</sup>

- Illinois ranks #2 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,682 foreign firms with unique 11,232 locations that employ more than 552,695 Illinois residents.
- Australian firms employ 8,751 Illinoisans at 150 distinct locations for 50 subsidiaries.
- Australia is Illinois' 11th largest FDI partner by employment.

C: Export statistics are based on Origin of Movement methodology by the Census Bureau which collects information from the Customs and Border Protection from bills of lading. Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commodity trading firms may be the exporter of record even though the products came from a different state/producer.
