TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$80.82 billion in 2024, a 2.5% increase from 2023, and a 35.2% increase from 2019. The preliminary agricultural adjusted figure for 2024 is \$81.97 billion, a 0.9% increase from 2023 and a 32.2% increase from 2019.
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^c
- 13 out of top 20 export industries increased since 2023.
- 18 out of top 20 export industries increased since 2019.
- 12 of the top 20 Illinois export partner countries have seen gains since 2023.
- 19 of the top 20 Illinois export partner countries have seen gains since 2019.
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and Canada in 2024

- Illinois exports to Canada totaled \$19.83 billion in 2024, a 4.4% decrease from 2023 and a 26.4% increase since 2019. Canada is Illinois' 1st largest export market.
- Illinois ranks 5th among the 50 U.S. states in exports to Canada.
- Illinois imports from Canada totaled \$63.82 billion in 2024, a 2.5% decrease from 2023 and a 70.9% increase since 2019. Canada is Illinois' 1st largest import market.
- Illinois ranks 1st among the 50 U.S. states in imports from Canada.

- Illinois is home to over 2,682 foreign firms with unique 11,232 locations that employ more than 552,695 Illinois residents.
- Canadian firms employ 57,265 Illinoisans at 1,502 distinct locations for 279 subsidiaries.
- Canada is Illinois' 3rd largest FDI partner by employment.
