## TRADE AND INVESTMENT STATISTICS

### Exports are a Vital Part of Illinois' Economy<sup>A</sup>

- Preliminary Illinois exports totaled over \$80.82 billion in 2024, a 2.5% increase from 2023, and a 35.2% increase from 2019. The preliminary agricultural adjusted figure for 2024 is \$81.97 billion, a 0.9% increase from 2023 and a 32.2% increase from 2019.
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.<sup>C</sup>
- 13 out of top 20 export industries increased since 2023.
- 18 out of top 20 export industries increased since 2019.
- 12 of the top 20 Illinois export partner countries have seen gains since 2023.
- 19 of the top 20 Illinois export partner countries have seen gains since 2019.
- Export activities support over 800K jobs in Illinois.<sup>B</sup>

### Total Trade between Illinois and Germany in 2024

- Illinois exports to Germany totaled \$4.42 billion in 2024, a 1.7% decrease from 2023, a 33.5% increase from 2019. Germany is Illinois' 5th largest export market.
- Illinois ranks 4th among the 50 U.S. states in exports to Germany.
- Illinois imports from Germany totaled \$8.52 billion in 2024, a 30.5% decrease from 2023, a 3% increase since 2019. Germany is Illinois' 5th largest import market.
- Illinois ranks 5th among the 50 U.S. states in imports from Germany.

### German Foreign Direct Investment in Illinois<sup>D</sup>

- Illinois ranks #2 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,682 foreign firms with unique 11,232 locations that employ more than 552,695 Illinois residents.
- German firms employ 70,905 Illinoisans at 1,332 distinct locations for 281 subsidiaries.
- Germany is Illinois' 2nd largest FDI partner by employment.
