TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$80.82 billion in 2024, a 2.5% increase from 2023, and a 35.2% increase from 2019. The preliminary agricultural adjusted figure for 2024 is \$81.97 billion, a 0.9% increase from 2023 and a 32.2% increase from 2019.
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^c
- 13 out of top 20 export industries increased since 2023.
- 18 out of top 20 export industries increased since 2019.
- 12 of the top 20 Illinois export partner countries have seen gains since 2023.
- 19 of the top 20 Illinois export partner countries have seen gains since 2019.
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and New Zealand in 2024

- Illinois exports to New Zealand totaled \$208.6 million in 2024, a 19.0% increase from 2023 and a 51.5% increase since 2019. New Zealand is Illinois' 40th largest export market.
- Illinois ranks 5th among the 50 U.S. states in exports to New Zealand.
- Illinois imports from New Zealand totaled \$560.9 million in 2024, a 19.0% increase from 2023 and a 29.4% increase since 2019. New Zealand is Illinois' 31st largest import market.
- Ilinois ranks 4th among the 50 U.S. states in imports from New Zealand.

C: Export statistics are based on Origin of Movement methodology by the Census Bureau which collects information from the Customs and Border Protection from bills of lading. Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commod trading firms maybe the exporter of record even though the products came from a different state/producer.

- Illinois ranks #2 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,682 foreign firms with unique 11,232 locations that employ more than 552,695 Illinois residents.
- New Zealander firms employ 6,479 Illinoisans at 69 distinct locations for 13 subsidiaries.
- New Zealand is Illinois' 13th largest FDI partner by employment.
