TRADE AND INVESTMENT STATISTICS

Exports are a Vital Part of Illinois' Economy^A

- Preliminary Illinois exports totaled over \$80.82 billion in 2024, a 2.5% increase from 2023, and a 35.2% increase from 2019. The preliminary agricultural adjusted figure for 2024 is \$81.97 billion, a 0.9% increase from 2023 and a 32.2% increase from 2019.
- Illinois is the largest exporting state in the Midwest and the 4th largest in the nation, using agricultural adjusted figures provided by Census Bureau/USDA cash receipts.^C
- 13 out of top 20 export industries increased since 2023.
- 18 out of top 20 export industries increased since 2019.
- 12 of the top 20 Illinois export partner countries have seen gains since 2023.
- 19 of the top 20 Illinois export partner countries have seen gains since 2019.
- Export activities support over 800K jobs in Illinois.^B

Total Trade between Illinois and United Arab Emirates in 2024

- Illinois exports to United Arab Emirates totaled \$785.5 million in 2024, a 3.2% increase from 2023 and a 95.2% increase from 2019. United Arab Emirates is Illinois' 19th largest export market.
- Illinois ranks 12th among the 50 U.S. states in exports to United Arab Emirates.
- Illinois imports from United Arab Emirates totaled \$228.2 million in 2024, a 37.6% decrease from 2023 and a 18.8% decrease since 2019. United Arab Emirates is Illinois' 38th largest import market.
- Illinois ranks 8th among the 50 U.S. states in imports from United Arab Emirates.

Emirati Foreign Foreign Direct Investment in Illinois^D

- Illinois ranks #2 in the nation and Chicago ranks #1 amongst largest metro areas for new and expanding corporate locations.
- Illinois is home to over 2,682 foreign firms with unique 11,232 locations that employ more than 552,695 Illinois residents.
- Emirati firms employ 820 Illinoisans at 19 distinct locations for 11 subsidiaries.
- United Arab Emirates is Illinois' 31st largest FDI partner by employment.

B: Export Employment Source – DCEO-REMI analysis using data from: Dun and Bradstreet, Census Bureau, NAR, The Trade Partnership via the U.S. Bureau of Economic Analysis and Moody's Analytics data. This statistic will be updated in spring 2025.

C: Export statistics are based on Origin of Movement methodology by the Census Bureau which collects information from the Customs and Border Protection from bills of lading. Has a known and important shortcoming especially regarding agriculture consolidation and consolidation in general at coastal ports. Logistics companies and commodity trading firms may be the exporter of record even though the products came from a different state/producer.

D: Foreign Direct Investment Data Source – Dunn and Bradstreet March 2025 (preliminary) *FDI employment data (domestic) is subject to market fluctuations and data modeling. **IL Foreign country employment reporting based on very modeled data and may show regional HQ employment rather than country level.
