BACHELOR OF SCIENCE, SPECIAL EDUCATION, PROFESSIONAL EDUCATION LICENSE (PEL)

Admission Criteria

1. Completion of all Foundations Courses with a grade of "C" or higher
2. A grade of "B" or higher in SPE 100
3. A grade of "C" or higher in all general education courses
4. Combined GPA (all post-secondary work, SIUE + Transfer) of 2.5 or higher
5. No more than 5 non-program classes remaining (Page 1 contains all the non-program classes)
- It is highly recommended to start the program with only two non-program courses remaining.
6. Completion of 42 semester hours (minimum)
7. Be in Good Standing at SIUE

The Special Education program starts a new cohort in the SPE Program courses every fall semester.

In order to be considered for the upcoming cohort, students must submit an Upper Division Application. The Upper Division Application opens after Labor Day each year and will have a **priority deadline of February 1**. Applications may be submitted after the priority deadline and will be considered if space is still available in the upcoming cohort.

Transfer students should communicate with the SPE Advisor as soon as possible in the academic year prior to transferring to SIUE.

Students must complete a field placement application one semester in advance of SPE 401, 402, 418 and 499. Applications will be sent to the student by the Placement Office.

Grade requirement for Licensure:

All professional education and content-area coursework that forms part of an application for licensure, endorsement, or approval that is received on or after February 1, 2012, must have been passed with a grade no lower than "C" or equivalent in order to be counted towards fulfillment of the applicable requirements.

Retention Policy:

Students must earn a grade of "C" or higher in all courses. Students must maintain at least a 3.0 GPA in professional education (CIED) and special education (SPE) courses to remain in the program. If the student fails to earn a "C" or higher in the CIED & SPE coursework and/or maintain the required 3.0 GPA, the student will be required to reapply to the program under conditions determined by the Program Director.
