Jim Monahan let the Council know that graduate student applications are down and that they have had some challenges navigating the new admission's application system, Slate. The previous system, Radius, will no longer be in use as of next week.

Lindy Wagner explained a new focus in Student Affairs added to the other three they already had, Fostering a Vibrant Campus Life Experience. She also mentioned that students who work on campus have a 95% retention rate. Because of this, Student Affairs has been working on ways to enhance student employment on campus. She also described a professional development series that is being offered twice a month and let them know that the two grants Student Affairs received previously were renewed.

Chris Slaten thanked Jim Monahan and Jill Smucker for the recent graduate student open houses that were held virtually. Jim Monahan also mentioned that the application fee is waived for the month of October for all students.

Chris has been working with the Provost and Chancellor on getting more money allocated to graduate student advertising resulting in triple the funding. He has been working with BAM, the marketing firm used by SIUE, on ideas to strategically market.

Chris described a new effort of the Graduate School to connect with graduate students, based on the results of survey he had organized. The survey indicated graduate students want to feel connected on campus. To enhance that, the Graduate School has started an event called Grad Connect. The first one in September however had not been attended by any students which could have been because of the heavy rain that day. The Council and Chris explored other ways that the sessions could be more effective.
