Discussion for a Staff Senate initiated Vote of No Confidence – Puts a group of staff in crosshairs; it is dangerous and can look back for the collective governance group. It was discussed to bring the Chancellor in for a "conversation." As he did not like the letter that was written when it came to negotiations and the Staff Senate recommendations regarding the clerical contract. Facilities Management currently under Chancellor; wants to change the "feel of the University – can't be done…it is different for everyone.

Staff not receiving raises for the past three years – Cindy Cobetto discussed a job audit she has been dealing with since April. Job duties are being added but HR does not want to give her more money. Concerned regarding retention of staff. There should be appropriate staff and faculty to support students. There are currently 1,350 staff members.
